Also required for the Online program is the 2-week Rude Awakening workshop (or equivalent therapy hours approved by SEA) to be taken either in year 1 or 2.

There is a **non-refundable/non-transferable deposit of \$150** due at time of application that will be applied to the cost of Practitioners Training.

**PAYMENT AGREEMENT for Practitioners Training:** The cost for the program is \$5,315.00 (\$5,096.80 for tuition, \$105 registration fee, \$105 materials fee\* and a \$8.20 student record archiving fee). The total cost of the program is due in full upon registration.
